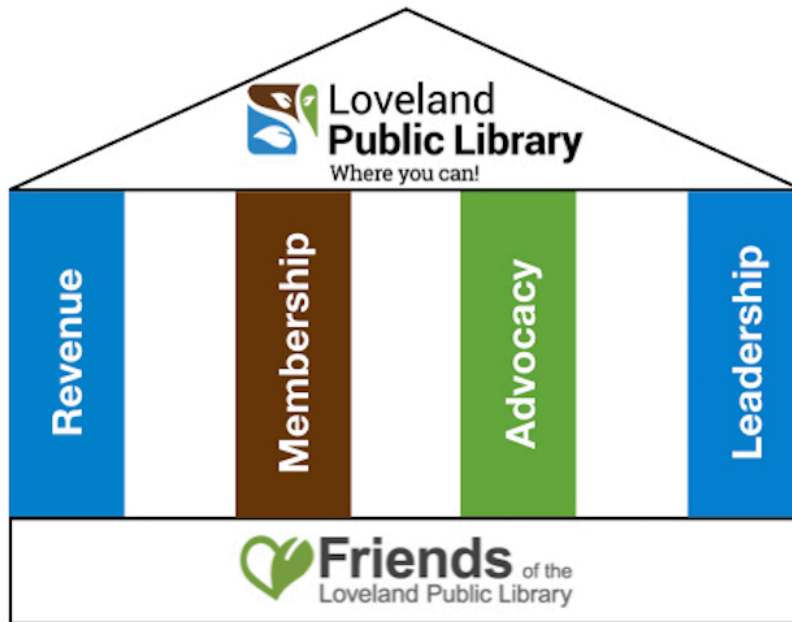

2019 Budget Notes

- New revenue sources include a book store in the library that should open about the middle of the year (pending some facility work by the city) and donations from the Northern Colorado Comic Conference (NoCo Com).
- Book cart will be eliminated when the book store opens.
- Rising interest rates and the repositioning of our reserve funds are resulting in higher interest.
- Net returns on book sales are decreased due to anticipated rental cost for a sorting place commencing in the last quarter of 2019 and rising costs at The Ranch.
- Newsletter printing and mailing expense is eliminated.
- Budget includes a 41% increase in spending on Library programs primarily in Technology and Teen Services.
- Designated funds other than Priscilla's Book Shelf have been eliminated.

Candidates for Board Membership

Nancy Arndt

Nancy worked at Interweave Press for 26 years. Much of that time she served as an editorial assistant, assistant editor, proofreader, and assistant production manager. For the past six years, she has been doing freelance copy editing and proofreading for them. She also does freelance proofreading for several other publishing companies. She is an active volunteer. For the past three years, she has sorted books at the Sorting Place and helped with the Friends book sales. Previously, she volunteered with the City of Loveland Police department destroying old files and helping with Teen Court, setting up files for the Loveland Museum, sorting and packaging bulk food for the Food Banks of Larimer and Weld counties, and in various church activities.

Besides reading, Nancy enjoys hiking and traveling. As a long-time resident of Loveland and a native Coloradoan, Nancy will bring valuable community perspective to the Friends Board.

Nancy Baker

Nancy had a long career in nursing and nursing management prior to her retirement in 2013 from The Joint Commission as a surveyor for home health agencies, hospice medical equipment providers, and home pharmacies. She has bachelor and masters degrees in nursing, an MBA from Keller Graduate School of Management, and significant work towards a Master of Theological Studies at Iliff School of Theology in Denver.

Nancy has been the Membership chair for the Friends since 2015, spending many hours updating and automating our membership records. She assisted the Long-Term Recovery Group of Northern Colorado following the 2013 Colorado flooding, and volunteered with the American Red Cross for the past six years. Quilting and genealogy are some of Nancy's favorite pastimes. Nancy's intimate knowledge of the Friends database and ideas for expanding our volunteer base will be very helpful on the Friends Board.

Janice Benedict

Janice's professional life has focused on books. Early in her career, she managed a small, independent bookstore. Then, she spent 30 years as a librarian, retiring a final time from the Loveland Public Library in 2017. In 2008, Janice received the Allie Beth Martin Award at the American Library Association convention for knowledge of books and the ability to share that knowledge with others. Janice has degrees in philosophy and English/American Literature, along with a Masters in Library Science from Southern Connecticut State University.

Janice has significant experience volunteering with the Friends. She sorts books for the book sales and remains on the Loveland Loves to Read committee, which she has participated in since its inception. Janice was on the Library Board for a short time, and has moderated the Readmore book discussion groups at the library for many years. She has also volunteered with the Colorado Master Gardener program. Along with her love of books and reading, Janice enjoys gardening and operas. Her vast experience in libraries and her history with the Loveland Public Library will be great assets to the Friends Board.

Mission Statement: The Friends of the Loveland Public Library Foundation, Inc. supports and advocates for the Loveland Public Library’s work as the information center of the community and its role in encouraging literacy. The Friends generates current and long-term funding through volunteer involvement.

Proposed:

Article II – Purpose

Section 2. Mission Statement: The mission of the Friends of the Loveland Public Library Foundation, Inc. is to support and advocate for the Loveland Public Library and its mission “to inform, enrich and inspire a strong, engaged community”. The Friends generate current and long-term funding through volunteer involvement.

2) Proposal to amend Article IV, Section 5

Current:

Article IV – Meetings

Section 5. A vote by email generated by the president is permitted as needed.

Proposed:

Article IV – Meetings

Section 5. Action without a Meeting / Electronic Voting

A vote by email generated by the president is permitted as needed. Any action required or permitted by law to be taken at a board of directors’ meeting may be taken without a meeting, subject to the following restrictions:

- a. Notice must be transmitted in writing to each member of the board;
- b. The number of votes required to take action must equal or exceed the quorum requirements defined in Section 4;
- c. If the president receives a written demand by a director that such action not be taken without a meeting, the board must hold a meeting to vote on the action.

3) Proposal to amend Article VI, Section 2

Current:

Article VI – Duties of Officers

Section 2. The Vice-President, or an appointee of the President, shall assist the President and, in case of the absence of the President, shall perform the duties of the President. The Vice-President, working with the editor of the newsletter, shall be responsible for oversight and content of the newsletter.

Proposed:

Article VI – Duties of Officers

Section 2. The Vice-President, or an appointee of the President, shall assist the President and, in case of the absence of the President, shall perform the duties of the President.

This painting and several other pieces of art displayed throughout the year were purchased by members of the community with a commission of 20% donated by the artists back to the Friends in support the library.



The Art Selection Committee is comprised of six members: two from the Friends, two employees of the Loveland Public Library, and two Loveland Public Library Board members. The committee sincerely hopes that everyone viewing the art is stimulated to thought and/or moved emotionally.

Our reserve of books was plentiful due to a robust inventory at the Sorting Place, and the selection on the cart was replenished regularly by volunteers. Book Sales – Sorting Place

Thanks to all of our volunteers who have done so much to make our Book Sales very successful! Since the last sale we have been swamped by a large number of donations, but we are finally making inroads into the backlog. This last year we received 15,000 (rough estimate) books from the estate of Dr. E. Vlachos, who was a professor at CSU. This bumped up the number of history and social science books at the last two sales and will do so again in April.

Last April we took an estimated 48,300 books to the sale, and sold 67% of them. We took 56,150 books to the fall sale, and sold 68%. We sorted, packed and then moved 1,922 boxes – that works out to almost 78 boxes sorted and packed per week!

All our volunteers deserve a shout out for their hard work and dedication to the enterprise. Special thanks go to Janet Wagner, who we think puts in more hours per week than anyone else and who accomplishes prodigious labors. We would also like to recognize the Tuesday crew, Annis Askew, Gene Fender, Susan Gagnon, Kathy Keeler, Debbie Kelly, Julie Muller, Peggy Pothast, Carol Spry, and Janet Wagner. They presort and pack all the incoming books, getting them ready for the sorters to do their special magic on Wednesdays. Jon Durnbaugh, who conducts online sales and shares the profits with the Friends, also comes in Tuesdays to help presort.

We have learned that the City of Loveland does not intend to tear down our current building during 2019, and so we'll be able to stay there at least through the Spring and Fall 2019 sales.
